44. MINUTES OF THE MEETINGS OF 9.11.2009 AND 26.11.2009

It was AGREED that the minutes, which had been circulated, be confirmed as a true record and signed by the Chairman.

45. MATTERS ARISING FROM THE MINUTES

<u>Minute 39, participatory budgeting.</u> It was noted that the applications made by the sports groups had been unsuccessful. It was hoped that they would be able to obtain grants from Broadland District Council.

Sergeant Scott gave details of crime in the Village, which was generally low. However some residents of a particular area had caused problems and the Police were working with Wherry Housing to deal with the people concerned.

The Chairman thanked the Police officers who left the meeting.

Mr Dunn spoke about Norfolk County Council's plans to turn of footway lighting during the night. He and many other members had not supported these plans and suggested that the Council voice its objections. (This had already been done.) The meeting was concerned that Norfolk County Council had decided to go ahead with its plans despite considerable opposition.
