1. ELECTION OF CHAIRMAN OF THE PARISH COUNCIL AND SIGNING OF DECLARATION OF ACCEPTANCE OF OFFICE

It was AGREED that Councillor J Leggett be appointed as Chairman of the Parish Council for the ensuing year. She signed the Declaration of Acceptance of Office.

2. ELECTION OF VICE CHAIRMAN OF THE PARISH COUNCIL

It was AGREED that Councillor B Sabberton-Coe be appointed as Vice Chairman for the ensuing year.

3. APOLOGIES FOR ABSENCE

Apologies were received and accepted from Councillor B Honess due to holiday commitments. Broadland District Councillor K Leggett also gave his apologies.

4. DECLARATIONS OF INTERESTS AND REQUESTS FOR DISPENSATIONS

There were no declarations of interests and requests for dispensations.

5. MINUTES OF THE MEETING OF 12.03.2018

It was AGREED that the Minutes, which had been circulated with the Agenda, be confirmed as a true record and signed by the Chairman.

6. MATTERS ARISING

There were no matters arising.

7. PUBLIC DISCUSSION

The meeting was adjourned for public discussion and Reports from the Police, County and District Councillors

As the Police were not present a written report for April was circulated, a copy of which is attached to the official minutes. Minutes of the Safer Neighbourhood Advisory Panel meeting held on 16th April were also circulated and are attached to the official minutes.

Norfolk County and Broadland District Councillor Karen Vincent gave an update on outstanding highways issues: 1) Chartwell Road/Spixworth Road. The Safety Audit had concluded that there were no areas of concern for this new junction. Councillor K Vincent will have further meetings with Highways to discussion concerns regarding the new junction. It was AGREED that Councillor J Leggett would submit a question to Norfolk County Council's Environment, Development and Transport Committee which is being held on 18th May. Councillors were requested to email the Clerk with their comments regarding the junction. 2) Development at Repton Avenue: Councillor K Vincent and Councillor J Leggett were continuing discussions with Planning at Broadland District Council regarding. 3) A reminder that the Norwich Western Link consultation was open until 3rd July. 4) Anglia Square development. It was believed that the public response to the development had not been positive to the tower proposal. 5) With the introduction of charges at the recycling centre

Councillor K Vincent requested that any instances of fly-tipping be report to her also. 6) Community-led Planning Programme. Run by Broadland District Council and South Norfolk Council these are a number of planning workshops will be available starting from June. 7) With regard to the County Councillors Allowance increase - Councillor K Vincent stated that she did not vote for the increase and has chosen to use the increase to support our community. If Councillors are aware of a local group or project that would benefit from "a little more help" please let Councillor K Vincent know.

The meeting resumed.

It was AGREED that the SYEP were permitted to hold x2 bbqs at the recreation ground (gas only). Council AGREED recommendations for a Community Working Group; the Clerk will "advertise" for residents to join a Community Working Group for the future planning of a community centre in Old Catton in the next edition of the Newsletter. The date for Norfolk Day was noted.

- 9.9 It was AGREED that the Clerk should attend the SLCC Norfolk Local Councils 2018 Conference on 15th June. Clerk to seek eligibility of training bursary to cover 50% of the cost.
