## 2. Minutes of the meeting held on 17th October were agreed.

## 3. Matters Arising and Result of priorities from the last quarter

Speeding on Wroxham Road

Traffic counts (number of vehicles and speed) had been carried out using bands across the road. The results show that 94.7% of traffic gong towards Norwich were complying with the speed limit and that 93.3% of traffic travelling towards Wroxham were complying. The Police consider that these results do not warrant a fixed camera nor the use of the police camera van.

Proctor Road traffic calming

Cllr Vincent has talked to NCC Highways who will not install more traffic calming measures due to exiting signage, speed bumps and comparatively low traffic counts

Speeding on Oak Lane

Two fixed penalty notices have been issued and words of advice given

# Results of last quarter's priorities

Parking at Wroxham Road Shops

The Police gave parking advice notices to the shops, residents reported the Fish Shop is the only shop displaying the signs

PCSO Casburn had seen an adult buggy unable to pass a vehicle parked on the pavement and issued a ticket. Residents report that parking is still a problem here.

Speeding on St Faiths Road

Intermittent checks have taken place, nothing of note to report, not been an issue recently

# 4. Public discussion

- Police reported that speeding offences by a young driver in a mini had been dealt with.
- Residents raised concerns about:-
  - a van frequently parked near the Merlin Avenue/Sparhawk Avenue junction which severely restricts vision. PCSO Casburn will investigate
  - A trailer parked on Wroxham Road. Trailers should only be parked on a road when attached to a vehicle. PCSO Casburn will follow up
- There was a general discussion about the ending of the PCSO's employment and the policing levels in the area. The Safer Neighbourhood Team will consist of one PC who is the beat manger.
